Coinciding with the second part of the fifth session of the Intergovernmental Negotiating Committee (INC 5.2), a new report published in *The Lancet* will offer an up-to-date assessment of the links between health and plastic pollution across the full life cycle of plastic and announces the launch of an independent, health-focused global monitoring system on plastics: The Lancet Countdown on Health and Plastics.

Inspired by the model and impact of the Lancet Countdown on Health and Climate Change (https://lancetcountdown.org), this new Countdown will track the impacts of plastic pollution on human health across all stages of the plastics life cycle, and monitor progress on addressing these impacts from a health perspective. It will identify and regularly report on a suite of scientifically meaningful and geographically and temporally representative indicators across all stages of the plastic life cycle. In doing so, it will provide independent data that can continue to inform decision-making for the benefit of public health.

This event will be an opportunity for delegates attending INC5.2 and stakeholders around the world to gather to hear:

- the latest evidence on the impacts of plastic pollution on human health;
- opportunities to address these impacts in the future plastics treaty to ensure protection of human health and the environment; and
- the contribution that the new Lancet Countdown on Health and Plastics can make as an independent data source to inform decision-making at all levels for the benefit of public health.
