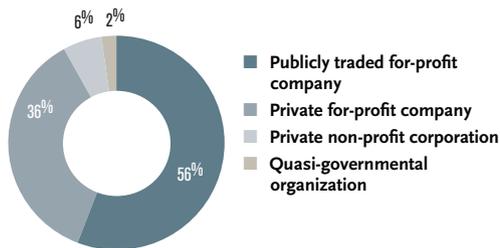

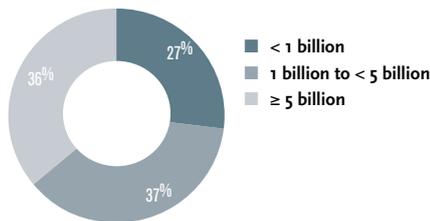

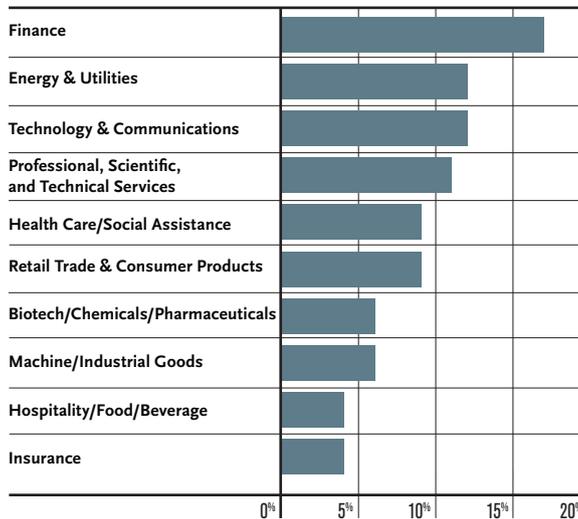
Company type
